Liability Release. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I _____, as parent or legal guardian of _____, a minor (hereinafter "Minor"), hereby grant the permission necessary to allow Minor to participate in the above camp to be conducted by JW Enterprises d / b / a Team Dance Academy (TDA). I, in my own behalf and on behalf of the Minor, further agree to release and to hold harmless TDA, the hosting site, (university, hotel, convention center, high school) on whose premises the Camp will occur (hereinafter the "Location") the affiliates of TDA and the Location, and the respective directors, officers, representatives, members, agents and employees of TDA, the Location and their respective affiliates (hereinafter collectively "Releasees") from any and all liability for negligence or any other claim judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the Camp, including any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and / or death) that the Minor may incur or sustain during the Camp, all activities associated with the Camp and while traveling to and from the site for the Camp whether or not the Camp actually occurs. I further expressly agree to indemnify and hold harmless Releasees and Releasees' heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by Minor or by any other persons on the account of damages of any character resulting to Minor in any way from the foregoing activities. I further agree to reimburse and to make good to Releasees any loss, or costs Releasees may have to pay as a result of any such action, claim or demand. I, in my own behalf and on behalf of the Minor, hereby warrant that I have read this Liability Release in its entirety and fully understand its contents. I, in my own behalf and on behalf of the Minor, am aware that this Liability Release releases Releasees from liability and contains an acknowledgement of my ,voluntary and knowing assumption of the risk of injury or illness. I, in my own behalf and on behalf of the minor, further acknowledge that nothing in this Liability Release constitutes a guarantee that the Camp will occur. I, in my own behalf and on behalf of the Minor, have signed this document voluntarily and of my own free will.

Medical Release. I, in my own behalf and on behalf of the minor, acknowledge and agree that such participation subjects Minor to possibility of physical illness or injury (minimal, serious, catastrophic and/ or death) and that I, in my own behalf and on behalf of the Minor, acknowledge that the Minor is assuming the risk of such illness or injury by participating in the camp. In the event of such illness or injury, I authorize TDA to obtain necessary medical treatment of the minor and hereby, in my own behalf and on behalf of the Minor, release and hold harmless Releasees in the exercises of this authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred on behalf of the Minor for any illness or injury that the Minor may sustain during the Camp and while traveling to and from the site for the Camp whether or not the Camp actually occurs.

Appearance Agreement. I understand that JW Enterprises d / b / a TDA from time to time produces promotional material relating to its programs. I understand that as a participant and/ or a spectator at the Camp that Minor may be included in videotapes or photographs taken during the Camp. Therefore, without reservation or limitations, I, in my own behalf and on behalf of the Minor, hereby assign, transfer and grant to TDA, its successors, assignees, licensees, sponsors, any television networks, and all other commercial exhibitors the exclusive right to photograph and/or videotape the Minor and to utilize such videotapes and photographs and Minor's name, face likeness, voice and appearance as a part of th e Camp, in advertising and promoting the Camp or in advertising and promoting similar future events. I further understand that neither Varsity Spirit nor any third party is under any obligation to exercise any of the foregoing rights, licenses and privileges.

Camp Rules. I further acknowledge and understand that TDA has established rules and regulations pertaining to conduct, behavior and activities of all Camp participants, by which Minor and I agree to abide during the Camp (copy of which is listed on the back of this form), and that Minor and I will be responsible for his/her/my failure to abide by those rules and regulations. Minor and I have received, read and understand the Camp rules. Minor and I understand that violation of the rules can result in dismissal from Camp with no refund.

General Camp Rules

1. Participants are required to wear name tags at all times.
2. Cheering, chanting and dancing will be practiced in designated areas ONLY.
3. Squads/teams must be on time to all classes and camp functions.
4. Please leave valuables at home (rings, jewelry, etc.). TDA will not be responsible for lost or stolen items.
5. Contact a member of the TDA management staff before seeking medical attention at a clinic or hospital (at camps where management staff is provided).
6. The use of alcohol or other illegal substances is prohibited.
7. Smoking at camp is prohibited.
8. Hazing or initiations of any type is prohibited.
9. No hanging signs without permission.
10. If attending an overnight camp (resort or resident), all participants must follow housing rules:
A) No running or unnecessary noise in the halls. **B)** All windows are to remain closed in the air-conditioned dorms/ resorts. In dorms/resorts without air-condition, windows may be left open, but screens must be left on. No leaning out of windows. No throwing anything out of windows. **C)** There will be no tumbling, horseplay, partner stunts or practicing in the dorm/resort. **D)** Any damage to the room will be charged to your group. Be sure to leave your room as clean as you found it. **E)** Some locations charge participants for lost keys. Please keep up with your keys. **F)** All participants must be in the building at 9:00 pm, on their floor by 10:00 pm, in the rooms by 10:30 pm and in bed with lights out by 11:00 pm and remain there until morning. If an emergency occurs, participants should contact the Camp Manager immediately for assistance. **G)** No one of the opposite sex will be allowed in the sleeping rooms. In addition to the general rules above, the following rules apply to specific camp types:

Resident Camp

1. Participants will not ride in cars while at camp. Participants must walk with their squads/teams to all camp functions. If participants bring their car, they must park their car and turn keys over to the Camp manager (if applicable). Participants are not allowed to leave the "camp" premises.

Private Camp

1. Participants must have an adult chaperone/coach in attendance at all times during the camp.
2. Medical Release Forms must be copied and the original mailed to the TDA office three weeks prior to camp. The coach is responsible for having copies of the squads/teams medical forms with him/her during camp.
3. Have an emergency plan.
